EPWS appointed to new DG Employment and Social Affairs Board

There was more good news for EPWS recently when EPWS was given a seat on the European Commission's Network of Women in Decision Making. Unlike the ERAB board to which EPWS President Adelheid Ehmke was recently appointed (see last month's newsletter) this Network is run by DG Employment and Social Affairs which means EPWS now gets to speak at the highest levels two different European Commission Directorate-Generals.

The 'Network of women in decision-making in politics and the economy' aims to provide a platform at EU level for successful strategies to improve gender balance in decision-making positions. Concretely, it will allow for exchange of ideas, information and experience, mutual learning and sharing of good practice. By facilitating partnerships and synergies between existing networks at European level, DG Employment and Social Affairs feels the group will provide a clear EU added value

The inaugural meeting, which was attended by EPWS Vice-President Brigitte Muehlenbruch, was opened by Egual Opportunities Commissioner Vladimír Spidla and by Zita Gurmai, Vice-Chairwoman of the European Parliament's Committee on Women's Rights and Gender Equality. Commission Vice-President Margot Wallström and Budget Commissioner Dalia Grybauskaité were also present for part of the meeting.

EPWS is very grateful to DG Employment and Social Affairs for giving us the opportunity to be part of this prestigious network, filled with



representatives from a host of dynamic and diverse organisations, and for allowing us voice the concerns of women in research and suggest the possible solutions to their needs.

EC launches new user-friendly web portal for Researchers

On 24 June 2008, EU Science and Research Commissioner, Janez Potočnik, launched EURAXESS – Researchers in Motion, the new brand overarching four initiatives for researchers to promote their mobility and career development.

The European Commission is intensifying efforts to promote the mobility and career development of researchers and thereby establish Europe as a leading area of excellence in scientific research. The objective of the Portal is to provide a single access point to information and support services which assist researchers and their families in moving to and pursuing careers in another Member State.

EURAXESS hosts the following initiatives: (former EURAXESS Jobs European Researcher's Mobility Portal) is a recruitment tool with constantly updated job vacancies for researchers throughout Europe; EURAXESS Services (former ERA-MORE Network) assists researchers and their families to organise their stay in a foreign country; EURAXESS Rights (European Charter & Code) sets out the rights and duties of researchers and their employers and EURAXESS Links (former ERA-Link) is a networking tool for European researchers working outside Europe (US, Japan)

First results of the ERC's Advanced Grants – low proportion of female applicants

A total of 2,167 proposals were received for the European Research Council's first round of Advanced Grants for which €517 million is on offer. According to the ERC President Fotis Kafatos "after the first evaluation stage, we can see that the overall quality of the proposals submitted is really excellent", there is however a severe shortage of applications from female scientists. Although the applicants represent 50 different nationalities, linked to host institutions in 36 different countries, only 14% are women. Kafatos acknowledged this underrepresentation is an issue saying "we are aware that the relatively low proportion of women applicants is a general problem in European research, especially in the target group of established researchers. This is a concern which the ERC will continue to address at every level".

Of the 2,167 proposals submitted 766 are in Life Sciences and Medicine, 997 in Physical Sciences and Engineering and 404 in Social Science and Humanities.

The top applicant is Italy, with almost 15 per cent of the applications, followed by the UK, France and Germany – together, the four countries account for 46% of the applications. The fifth placed country is Israel at just over 6 per cent of the total.

Budapest wins contest to host EIT

Budapest has been picked to host the headquarters of the newly created European Institute of Technology and Innovation (EIT).

On June 18 2008 the 27 European research ministers supported the Hungarian capital's bid after Poland withdrew its bid to locate the office in Wroclaw.

"I'm very glad that we were able to take the decision as each day without the EIT seat is a day wasted," said Slovenian Minister for Higher Education, Science and Technology Mojca Kucler Dolina, who was chairing the meeting. The decision represents the final step in deciding on the establishment of the EIT, and will enable it to start its work without further delays, the minister said. New EC State Aid rules assist female entrepreneurs

At the start of this month the European Commission adopted a Regulation, which will come into force in the coming weeks, giving automatic approval for a range of aid measures and therefore allows Member States to grant such aid without first notifying the Commission.

The new Regulation authorises aid in favour of small and medium size enterprises (SMEs), research, innovation, regional development, training, employment and risk capital. The Regulation also authorises aid measures promoting entrepreneurship, such as aid for young innovative businesses and measures tackling problems, like difficulties in access to finance, faced by female entrepreneurs.

Aid for enterprises newly created by female entrepreneurs is a new category of state aid which until now had not been permitted.

Commission unveils plans for cooperation between national research programmes

The European Commission has set out its plans for boosting cooperation between national research funding programmes. The new 'Joint Programming' scheme is designed to ensure that public research funds are used as efficiently as possible, and help Europe tackle shared problems more effectively. The first Joint Programming Initiatives should be launched by 2010.

Just 15% of public research funds in Europe are allocated at the European level, either through the EU's own framework programmes, or through intergovernmental organisations such as CERN (the European Organisation for Nuclear Research) or pan-European schemes like EUREKA. The remaining 85% is locked up in programmes which are designed and implemented nationally.



Currently, there is little collaboration between these national research programmes, although many of the challenges they address are shared by all European countries.

'Challenges such as food safety, healthcare, marine ecosystems and biodiversity, climate change and energy are not confined to Member States borders, so research should be done jointly, and not simply nationally,' explained EU Science and Research Commissioner, Janez Potocnik.

ScienceBusiness launches first pan-European awards programme for enterprise on campus

The first pan-European awards programme to recognise academic entrepreneurs was launched in June 2008 at INSEAD's Europe campus, Fontainebleau, by the Science|Business Innovation Board, a panel of leaders in industry, academia and policy.

The Academic Enterprise Awards Europe 2008 programme has already been backed by representatives of 24 universities and institutes in Europe – including Imperial College London, ETH-Zürich, University College London, Stockholm's Karolinska Institutet, business schools INSEAD and ESADE, and the Isis Innovation arm of Oxford University.

It is the first awards programme across Europe to focus on university spin-outs and their founders – often cited as a vital source of innovation in Europe – and will be open to academic entrepreneurs and entrepreneurship enablers across the continent.

Nominations for prizes in 7 categories open online in July at www.sciencebusiness.net, and the contest concludes on 2 December 2008 in Stockholm at Karolinska with final judging, a conference on academic enterprise and an awards ceremony. Winners will receive public

recognition for their achievement and a chance at investment by corporate and individual investors invited to review nominees.

FEBS/EMBO Women in Science Award

The FEBS/EMBO Women in Science Award is a joint initiative of the Federation of European Biochemical Societies (FEBS) and the European Molecular Biology Organisation (EMBO). Launched in 2007, the aim of the award is to highlight the major contributions made by female scientists to life sciences research. Winners of the award will serve as inspiring role models for future generations of women in science.

Each year an individual woman working in the life sciences will be recognised for her exceptional achievements. The winner will be honoured at the annual FEBS Congress, where she will receive a grant of €10,000 and present a special plenary lecture. The first award will be presented at the 2008 FEBS Congress in Athens, Greece.

The nominee must be a woman who has made significant contributions to her field of science in the last 5 years. The award is generally not meant to be for lifetime achievements. The nominee's research must be based in one of the FEBS or EMBO member countries and in a scientific field covered by FEBS and EMBO, i.e. the life sciences, including medical and agricultural research.

The deadline for nominations for the Award in 2009 is 1 September 2008

International Taskforce on Women and ICTs in Europe (ITF-Europe)

EPWS is delighted to announce the recent decision to set up a branch of the International Taskforce on Women and ICTs in Europe (ITF-Europe).

The International Taskforce on Women and ICTs (ITF) was launched in November 2006 to create synergy in international work to increase women's participation in ICTs. Guided by the principles in the Declaration of Agreement (http://www.umbc.edu/cwit/Declaration.html) that serve as its foundation, the ITF promotes communication and information exchange, including the sharing of research, knowledge, and resources.

The vision of the ITF is to create an information society for sustainable global development that fosters the potential for success of all its members. The overarching goal is to ensure women's full participation in this inclusive information society as leaders and creators, as well as users of ICT.

In March 2008 the plans for setting up of the European Centre were presented in Brussels in three fora:

- 4 March 2008 in the High-level meeting of the e-skills Industry Leadership Board
- 6 March 2008 during the EU Conference arranged by the European Commission: Move out from the Shadow: Seize the OpportunITy!
- 7 March 2008 the 1st Multi-Stakeholder Partnership meeting was hosed by the ITF and sponsored by the Commissions DG INFSO.

Thereafter the decision was taken to set up the International Taskforce on Women and ICTs in Europe (ITF-Europe) as a temporary group acting in a similar way and engaged in similar goals as the ITF but in the European regional context and assisting the start-up and the work

of the European Centre for Women and Technology.

The Secretariat of ITF-Europe is at the Regional Innovation Centre Papirbredden Innovasjon in Drammen, Norway.
