RECENT DEVELOPMENTS

Gender in technological transfer positions: final conference in Barcelona on 11/13 June 2008.

WIST - Women in Innovation, Science and Technology is a two years project funded under FP6 with the aim to analyse the role of gender in technology transfer positions.

The WIST project examined the participation and position of women in transfer, incubation and entrepreneurship (TIE) organisations, especially technology transfer offices of the universities, science parks and other networking organisations, which aim to facilitate the interaction between science and society by bringing together actors from universities, enterprises, policy making and societal services. The science/society dialogue is enhanced by helping researchers to turn their research results into commercial products and services, or by supporting new kinds of university/industry alliances.

The research was conducted in four EU countries in which the TIE sector has developed and is organised differently. Larger countries are represented by Germany and the UK, Romania is one of the transition countries in the EU and Finland is a typical small Nordic welfare state.

The WIST project has analysed both statistical data and interview data. Five case organisations were selected in each partner country. The chief executive officers of TIE organisations and 25 female experts were interviewed in each country during summer and early autumn of 2007 to get a picture of the field. The female expert interviews dealt with their personal career history, contents of work, TIE organisations as working places, networks and contacts and work life balance. The organisations were selected from engineering and biotechnology fields, universities and research institutes and in high-tech and aspiring regions.

Supporting Women in Scientific Careers - Joint ADVANCE and ENCOUWOMSCI Conference, Brussels 26/27 June 2008

The final conference 'Supporting Women in scientific careers' of two EU-projects was held in Brussels on June 26th and 27th, 2008. ADVANCE and ENCOUWONSCI are funded by the 6th Framework Programme for Research and Technological Development to improve the situation of female scientists in the European Union.

At the conference, the two projects presented their experiences and results achieved by recent seminars, training modules and mentoring. Central was the conference's role as a platform for information and exchange on good-practice examples from the two projects.

Attended by over 50 representatives from 21 European countries, the conference highlighted the current and future impact of training activities for encouraging women scientists. This was done by opening a wider debate on the scientific community and the scientific culture in Europe, on policy making processes and social aspects of science.

Prominent speakers on the first day included Dr. Liisa Husu, University of Helsinki; Dr. Brigitte Mühlenbruch, EPWS Vice-President; Prof. Dr. Ene Ergma, Former Vice President of the Estonian Academy of Science and current President of the Estonian Parliament; Prof. Marina Calloni, University of Milan; Julia Kzyshkowska , University of Heidelberg; and Alina Ligia Dumitrescu, Romanian Academy.

Report on Women and Science by the European Parliament

Ms Britta Thomsen - Danish MEP (PSE)- took the initiative to promote a report on the situation of women in science.

The report was submitted to FEMM Committee in February 2008 and its shadow Rapporteur was Mr Den Dover (EPP-ED, UK and Member of the ITRE Committee). The report was adopted by the Plenary on May 21st.

The adoption of the Thomsen proposal supports the European Commission policy on women and science, in its various initiatives: role models and mentoring schemes promotion, supporting network's initiative, awareness raising amongst the scientific community and policy makers, the respect of the non-binding quota of at least 40% of women in each scientific domains, special programmes increasing young girls' and women's interest in starting scientific careers, fight against stereotypes and pay gap, etc.

Benchmarking policy measures for gender equality in science

In 2002, the Helsinki Group in Women in Science, made of representatives of the Member States and gender experts, published a report on national policies on women in science which also included the national statistical profiles. The "Benchmarking national policies on gender equality in science" report provides an update on the national policies and on the statistical profiles of the 33 countries represented in the Helsinki Group, and it introduces for the first time data on the Western Balkans. This report builds on the previous one and evaluates the policies and measures with indicators measuring the presence of women in science. It gives an interesting and original overview on the various national situations and tries to develop a European synopsis. Science and Society/Citizens and governance in a knowledge-based society

A series of gender monitoring studies were launched during FP6 (five lots each covering several activity areas, a separate study for DG INFSO and a coordination contract) designed to monitor progress towards gender equality and gender relevance awareness in FP6. The studies examine both the participation of women in FP6 activities and the gender dimension of the research content, the aim being to assess the success of current gender mainstreaming strategies and to provide recommendations for future activities in this field.

This report presents the results of the study for the activity areas Citizens and Governance in a knowledge-based society; support for the coherent development of policies (including related policy-oriented research) and Science and Society. The study results indicate that under the research areas relevant to this study, a significant contribution has been made in FP6 in terms of progress towards gender equality. The European Molecular Biology Organization (EMBO) and the Federation of European Biochemical Societies (FEBS) are pleased to announce the second call for nominations for the FEBS/EMBO Women in Science Award.

The aim of this award is to highlight the major contributions being made by female life scientists to European research and to present inspiring role models for future generations of women in science.

Nominees should be excellent women scientists working in Europe who have made outstanding contributions to life sciences research in the last 5 years and significantly advanced our understanding of a particular discipline.

Their research can be in any area of the life sciences including agricultural and biomedical research.

Each year the award will recognise and reward the exceptional achievements of one woman working in the life sciences in Europe. The winner will be honoured at the annual FEBS Congress, where she will receive an award of 10,000 EUR and present a special plenary lecture. The first winner is Naama Barkai of the Weizman Institute of Science in Rehovot, Israel, recognized for her outstanding contributions to the field of systems biology and the mathematical modelling of biological systems. The award will be made on 2 July at the 2008 FEBS Congress in Athens, Greece.

The politics of knowing: research, institutions and gender in the making, 27-28 November 2008, Prague, Czech Republic

Science today, perhaps more than ever, is the site of multiple negotiations.
